The nomination forms can be obtained free of charge from the office of the Returning Officer of the Society, 211-213 Vardhman Diamond Plaza Deshbandhu Gupta Road, Paharganj New Delhi 110055 on 18.01.2025 from 10.00 a.m. to 04.00 p.m. Nomination forms duly filled alongwith Rs. 1000/- per nomination in cash as Security Deposit should be handed over to the undersigned personally by candidate or proposer or seconder on the date and time mentioned above. A person shall not be eligible to contest election for two posts simultaneously. Further, the Candidates, Proposer & Seconder shall not be a defaulter. A member shall not be eligible to contest for the election if he has not completed minimum period of one year from the date of acquiring membership in the Society to the date of filing of the nomination. In case the candidate gets less than 1/8<sup>th</sup> of total votes polled, the security deposit shall be forfeited or such candidates shall be disqualified for contesting the election in the Society for a period of three years.

The list of members and the list of defaulters of the aforesaid Society shall be displayed at the notice board of the undersigned and at the office of the Society. Members can obtain a copy of the list of members from the office of the Returning Officer of the Society on payment of prescribed fee, (@ 50/- only per hundred members) as per provision of Delhi Coop. Societies Rules, 2007, as amended from time to time.

Note: As per the provision of the D.C.S. Act-2003 and D.C.S. Rules 2007 the defaulter members are neither eligible to contest the election, nor entitled to cast their votes.
